Goa

- Order - Curfew extended till 26th July- Restriction, Prohibition & Advisory for strict compliance on following things under section 144 in North Goa district (18-07-2021)
- Order - Curfew extended till 26th July- Restriction, Prohibition & Advisory for strict compliance on following things under section 144 in South Goa district (18-07-2021)

Manipur

- State Disaster Management Authority, hereby extends the "CURFEW" for another seven days w.e.f.28.07.2021 to 03-08-2021 with relaxations (27-07-2021)
- Order: Imposition of "CURFEW" in the entire State for ten days w.e.f. 18th July to 27th July 2021 (19-07-2021)

Meghalaya
