ORDERS BY THE GOVERNOR OF MANIPUR


Imphal, the 1st June, 2021

No.MED-1706/10/2020-HS-HEALTH: In partial modification of Order of even number dated 26th May, 2021 for fixing the upper limit of charges for COVID-19 treatment in private hospitals, the Governor of Manipur is pleased to order the following modifications:

SL No.	Category of bed	Maximum charges per day (in Rs.)
1	General/Isolation	3,000/-
2	High Dependency Unit (HDU)	7,000/-
3	ICU without ventilator use	8,000/-
4	ICU with ventilator use	10,000/-


2. (a) The per day charges above includes the following:
- i. Registration charge
 - ii. Bed charge
 - iii. Nursing and boarding charge
- (b) Medicine and Drugs may be charged as per actual usage with maintenance of proper records and sharing of details on a daily basis with the patient party.
- (c) Oxygen may be charged separately at a reasonable rate. GoI/State Government guidelines for Rational Use of Oxygen for Management of COVID-19 to be ensured and specific records of oxygen given to each patient to be maintained.
- (d) Pathology and Radiology test may be charged separately as per normal rates with records of prescription by Doctor.
- (e) Extra medical procedure such as caesarean section, emergency surgery etc may be charged separately.
3. It is reiterated that high end medicines like Remdesivir can be charged separately at the rate of **Rs.3,400/-** per dose (i.e. the current GoI prescribed rate). PPE costs maybe charged separately based on actual use and the cost should be sub-allocated among patients based on rounds taken by the doctors/nurses.
4. PMJAY and CMHT beneficiaries are covered for COVID-19 hospitalization expenses. Their bills will be processed as per PMJAY/CMHT norms and procedures.

5. It is also clarified that private hospital staff are covered under the Pradhan Mantri Garib Kalyan Package: Insurance Scheme for Health Workers Fighting COVID-19 subject to Scheme guidelines and numbers as indicated by MoHFW.
6. Private hospitals are to strictly comply to the above rates and ensure that affordable COVID treatment is accessible to all.
7. This issues with approval of the Competent Authority.
