**ORDERS**

Imphal, the 29<sup>th</sup> January, 2022

In continuation of orders of even No. dated 08.01.2022, 15.01.2022 and 20.01.2022, the undersigned, in exercise of the powers conferred under Section 20(2)(a) of the Disaster Management Act, 2005 in his capacity as Chairperson, the State Executive Committee of the State Disaster Management Authority, in view of huge increase of infection by the highly mutant Covid-19 variant B.1.1529 (Omicron) in the country, hereby orders the following with immediate effect :


- i. Night curfew from **9 P.M. to 5 A.M.** shall be enforced strictly.
- ii. Micro containment zones shall be strictly monitored by dedicated Police Department teams and Health Department teams. DCs to involve the local Clubs / local bodies with specific jurisdictions.
- iii. Fresh cases of Covid-19 infections shall be isolated as soon as possible.
- iv. Health Department shall scale up vaccination, contact tracing and testing by providing additional manpower, mobility support and IEC-Advocacy.
- v. **Gathering is allowed subject to maximum of 50 (fifty) persons or half of the capacity whichever is less in case of closed spaces and maximum of 200 (Two hundred) persons in case of open spaces.**
- vi. All establishments of Print and Electronic Media and essential services and movement of their personnel are allowed during curfew.
- vii. **Revised list of activities permitted in the state is at Annexure.**

2. **Wearing of face masks in public places, gatherings and crowded areas is a critical Covid Appropriate Behaviour and it should be strictly enforced and violators to be penalised promptly under relevant rules.**

3. Deputy Commissioners shall issue necessary orders and Superintendents of Police shall take necessary action to implement the orders strictly.

4. This order shall remain in force till 28.02.2022.

5. High Court may issue orders in respect of Judicial Courts.

**List of permitted activities.****A. Government offices, PSUs and other public utilities.**

- i. All Central and State Government offices and shall function with **66% physical attendance of all employees** by taking adequate precaution and strictly following Covid Appropriate Behaviour.

**B. Shops and Establishments.**

- i. All shops and commercial establishments except the ones mentioned below may open from **8 AM to 5 PM.**
- ii. Shops selling fish, poultry and poultry products, Milk and fresh milk products from **8 AM to 1 PM.**
- iii. In respect of shops in Thangal and Paona Bazar the shops may open from **7 AM to 5 PM.**
- iv. Shopping Malls should ensure **limiting the number of customers to 50%** inside the Mall and strict observance of Covid Appropriate Behavior.
- v. Eating areas of hotels or Restaurants shall allow and serve only **50% of their capacity.**
- vi. Gymnasiums and Fitness centres may open **from 5 am to 1200 Noon.**

**C. Educational institutions.**

- i. Physical Classes should be only for class IX and above and number of students should not exceed 50% of the capacity of the classroom.
- ii. Online classes should be increased and physical classes reduced.
- iii. Only online classes in coaching centres and private tuition centres (No physical classes).
