ORDER

Sub: PSEC – Containment of Resurgence of COVID 19 – Instructions –
Issued

Ref: 1. Order No.40-3/2020-DM-I(A) dt.23/03/2021 of the Ministry of
Home Affairs, Government of India.

2. The Instructions of the High Level Committee held under the
Chairmanship of Hon'ble Lieutenant Governor vide
No. 1089/Secy (Health)/PS/2021, dt. 09.04.2021


Whereas there is a fresh surge in COVID-19 cases, in the Union Territory of Puducherry, along with other parts of the country. The Ministry of Home affairs issued guidelines for effective control of COVID-19 vide Order reference 1st cited above, which will be in force upto 30.04.2021. A copy of the said order is enclosed for strict compliance by all concerned.

2. In order to contain the resurgence of COVID-19 in the U.T. of Puducherry and in the light of decision in High Level Committee under the Chairmanship of Hon'ble Lt. Governor, held on 08.04.2021 the following directions are issued under Disaster Management Act, 2005.

1. Covid appropriate behaviour at all public places including wearing of Masks shall be ensured.
2. Social distancing and hand sanitizers equipment shall be kept at all shops and strict enforcement on Covid appropriate behaviour to be followed..
3. Corona Curfew shall be observed from 12.00 midnight till 5.00 am.
4. Industries shall be permitted to function by strictly following the Standard Operating Procedures (SOP) already issued by Government. Industrial establishments shall arrange for the vaccination of their employees based on the guidelines issued by Government of India from time to time. The industries and organisations shall be liable for strict action in case of violation of the SOP.
5. Following the SOP (no entry for general public without mask), restaurants, food courts and tea shops shall be permitted to operate till 11.00 pm with 50% of seating capacity. Take away (parcel food) will be permitted upto 11.00 pm. Recreation Clubs shall be permitted to function with 50% seating capacity.
6. Cinemas/Theatres/Multiplexes shall be permitted to function with 50% of the seating capacity by following the SOP issued already.

7. Social/ political/academic/entertainment/ sports/cultural/religious and other functions shall adhere to Covid Appropriate Behaviour namely social distancing, wearing mask & using sanitizers, etc.
8. All religious places/ places of worship shall be permitted for public worship till 10.00 pm by strictly following the SOP.
9. Rental vehicles and Taxis including Cab aggregation shall be permitted to ply with three passengers excluding driver. However, there shall be strict enforcement of the restriction imposed on the number of passengers.
10. Autos shall be permitted to ply with two passengers excluding driver. However, there shall be strict enforcement of the restriction imposed on the number of passengers.
11. Public transport especially buses shall be permitted for the available seat capacity only. No extra passengers are allowed. Sanitation at the entry point must be facilitated.

All departments/stakeholders concerned shall comply with aforesaid directions, along with guidelines issued by MHA vide its order cited 1st above for effective control of COVID-19.
